Rebecca, an AIP service provider, selected and installed a nonslip tile for her client's bathroom floor. However, the tile wasn't slippery enough for her client with Parkinson's disease who necessarily shuffled his feet when walking. Her client tripped and fell on the unforgiving tile floor and was injured.

# AIP Contractor Contractual and Legal Considerations cont.

- Even responsible service providers risk legal claims and lawsuits; therefore, they must protect themselves.
- Liability protection:
  - Use the best practices and materials that the budget permits.
  - Do not present yourself as an expert on matters other than those that relate to your profession.
  - Keep your insurance coverage in force.

### Authorizations for AIP Projects

- As an AIP service provider, you should:
  - Protect your clients' privacy and dignity.
  - Reassure your clients and their families that all personal information will be kept confidential.
- The Personal Information Protection and Electronic Documents Act (PIPEDA) provides for penalties for not complying with patient confidentiality.

# Authorizations for AIP Projects cont.

- Commercial enterprises must have a personal privacy agreement with their AIP clients
- Federally, PIPEDA is administered by the Privacy Commissioner's Office which has downloadable guidelines on the web
- Privacy laws are different in every province (in PEI and the Territories, PIPEDA applies directly)
- Specific forms for personal privacy agreement are unique to each province, there is no standard form that applied across Canada

### Authorizations for AIP Projects cont.

- CAPS contractors don't have training or license to interpret medical information:
  - Rely on the HCPs' recommendations or clients' requests.
  - Ask HCPs to examine and sign off on the design solution as part of the contract approval process.







